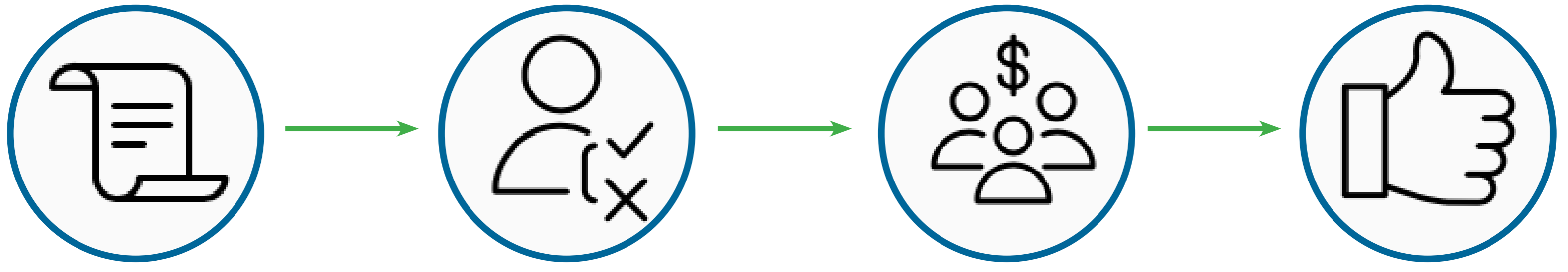

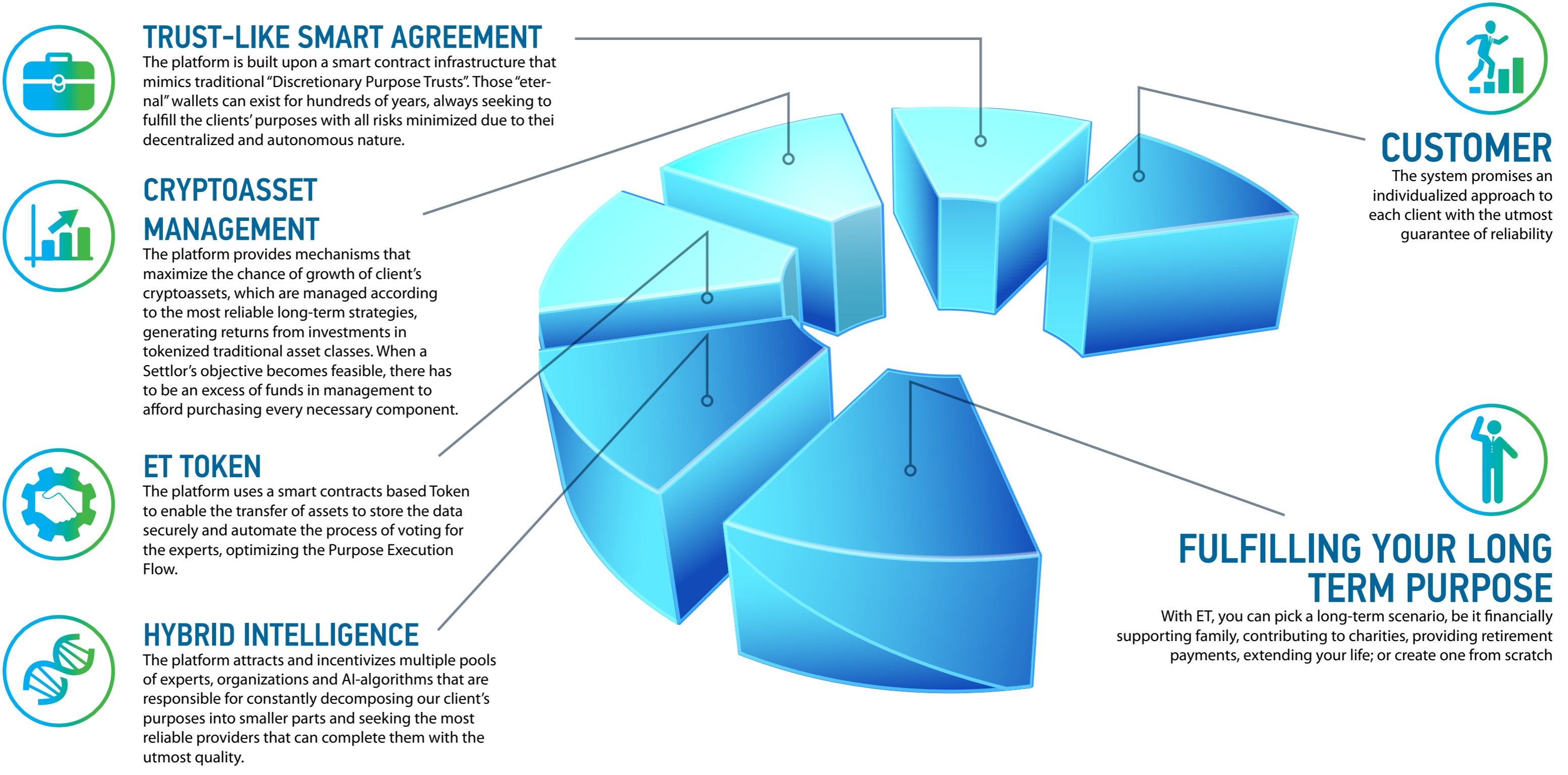

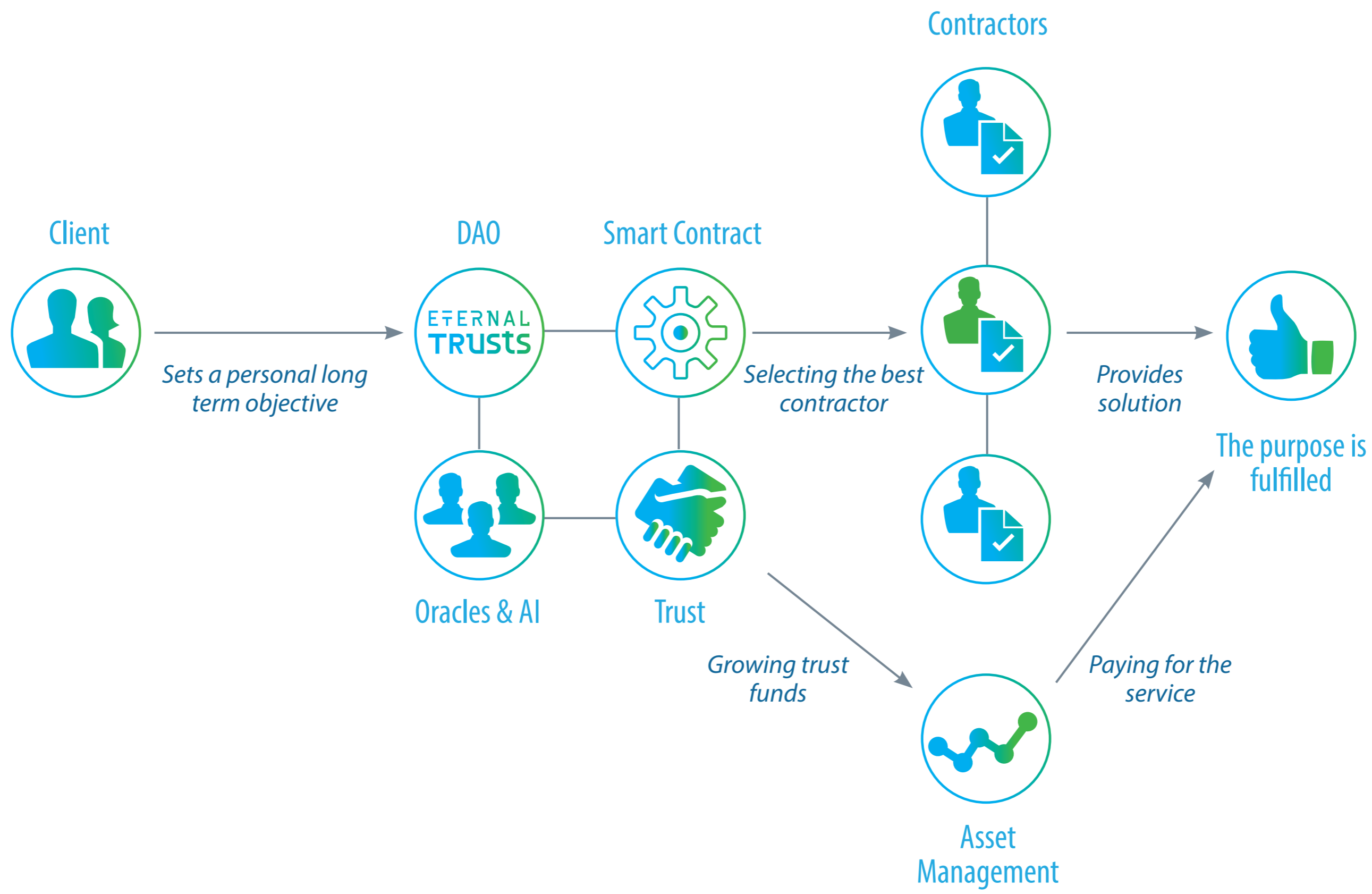

THE PURPOSE EXECUTION FLOW

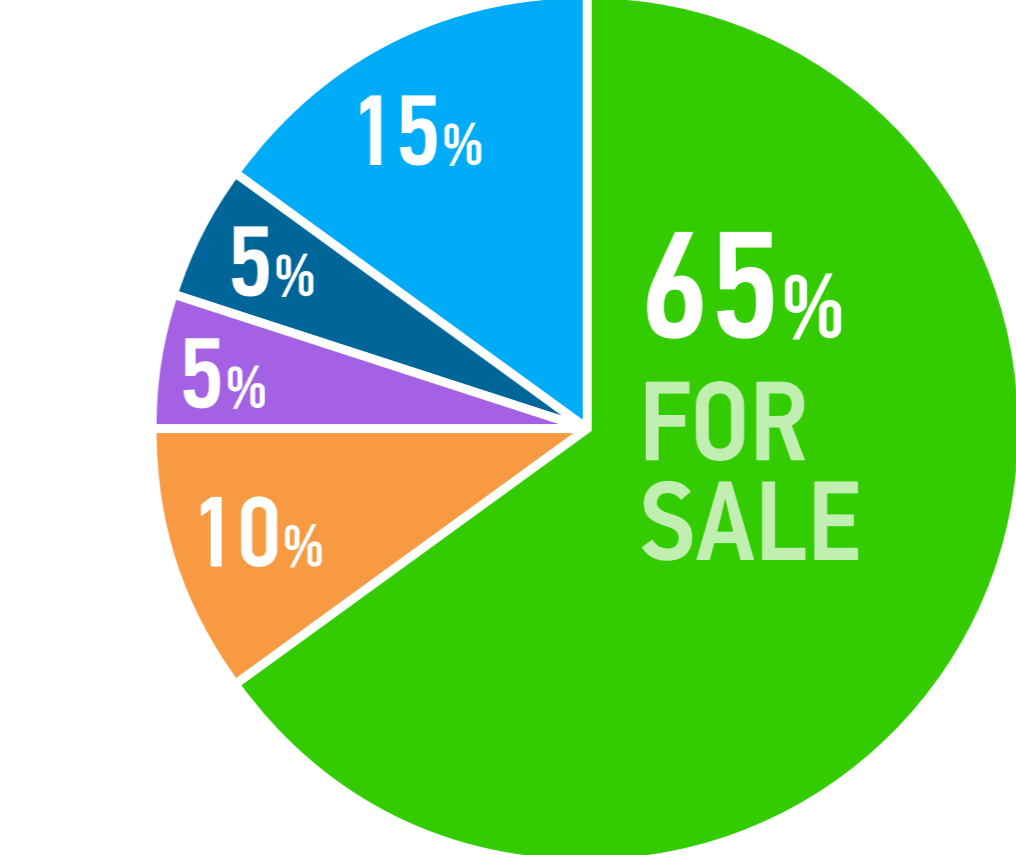
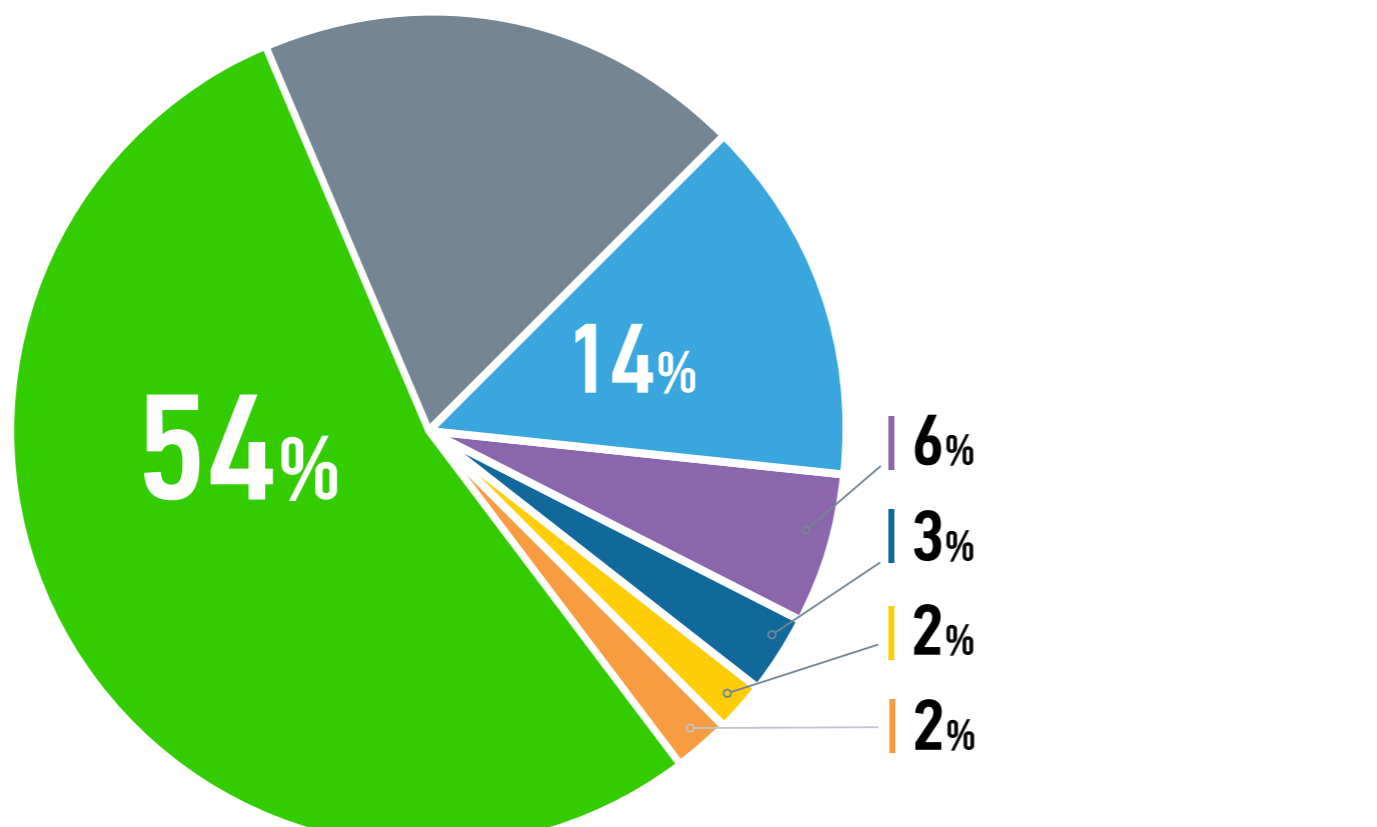
